The Property is in Riddings, Derbyshire, 2 miles south of Alfreton, and set within the established Amber Business Park.

The location benefits from excellent transport links due to its immediate proximity to the A38, which provides direct access to Junction 28 of the M1 approximately 2.4 km (1.5 miles) distant.

Alfreton is well served by public transport connections with regular bus routes and Alfreton Railway Station is located 3.5 km (2.2 miles) north of the property. The main estates in Alfreton and its surrounds continue to maintain a high level of occupation.
