Location

The property is located in Rotherham, South Yorkshire approximately 5 miles north east of Sheffield and has an urban population of 257,800. It benefits from excellent transport links in the form of the M1 and M18. The M1 provides direct access to the North (Leeds and Wakefield) and South (Nottingham, Milton Keynes and London). In addition, the M18, accessed at Junction 32 of the M1, provides access to the Humberside Ports.

Situation

The property is situated on the successful Magna Business Park development approx. 1.0 mile from J34 M1 giving excellent connectivity to Yorkshire, the Midlands and, via the M18 and M62, to the Humberside ports.

Description

The premises comprise a high quality, steel portal framed warehouse/distribution unit with ancillary offices constructed in 2007. The unit benefits from the following specification:
