Internally, the units are open plan, with a small welfare block included in each unit. Externally, the units benefit from a shared, secure yard area, with room for vehicle parking in front of each unit.

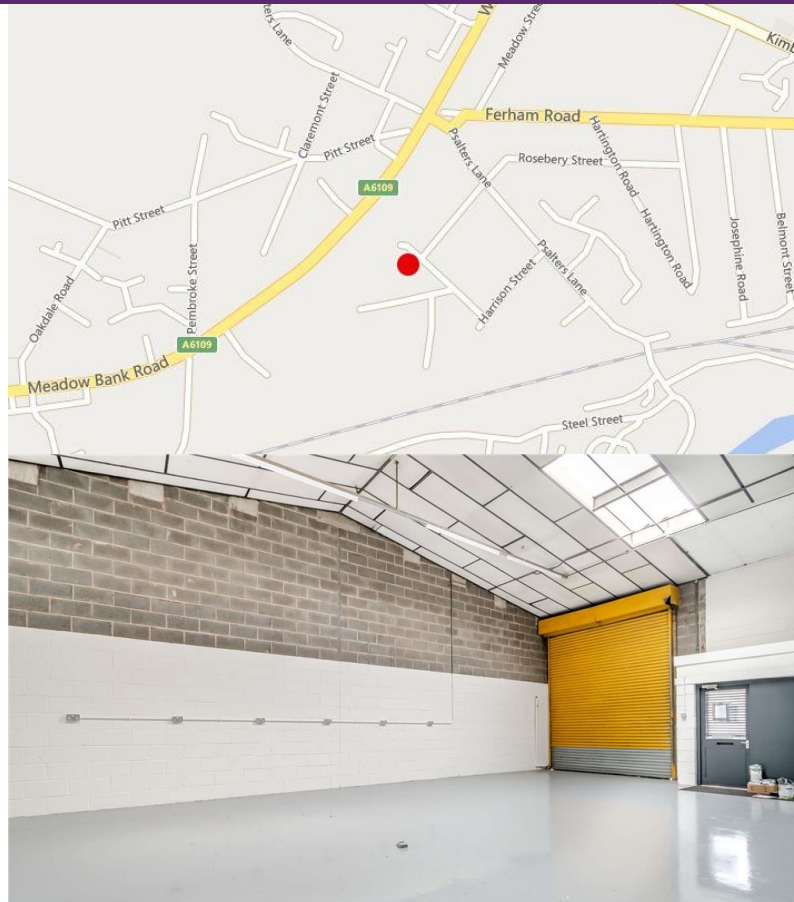
