The property is located fronting Rawson Spring Road close to Penistone Road (A61) in Sheffield. The estate is a short distance from the Hillsborough Football Ground and established Hillsborough Trade Point business Park.

Description

The estate comprises 3 industrial units arrange in 2 separate buildings with Units 1 & 3 being semidetached. Unit 1 provides access via a new roller shutter loading door leading from the shared yard area.

The unit provides a separate personnel entrance that leads into the single story office/reception area. Externally the units benefit from a shared yard/parking area with additional parking areas to be created along the side elevation.


