Location

Acton Grove forms part of the Acton Road Industrial Estate positioned off Fields Farm Road on the South side of Long Eaton town centre. Access to J25 of the M1 is via B6002 to the west and to the A50 (M1-M6 Link) via the B6540, to the south linking to J24 of the M1. All within 4 miles drive.

Key occupiers located nearby include Mi-Hub, Duresta, Travis Perkins and many established businesses associated with the furniture and upholstery sector prominent in the town.

Description

The property comprises a portal frame building with brick and blockwork elevations, providing accommodation over 3 bays. The units have pitched composite cement panelled roof coverings, concrete floor slab and the following additional features:


A range of floorspace is available, subject to sensible divisions of the building.
