The property fronts a prominent position on London Road at its junction with Hill Street. The subject site compromises an end terrace of three storey brick construction beneath a double pitched slate covered roof.

The ground floor is currently occupied by the Mind Charity and has its own entrance directly off the street. The upper parts were previously used for treatment rooms and offices and are accessed from a door off the side of the building, leading directly into a stairwell to the upper floors. The upper parts are entirely independent from the ground floor demise.

Externally to the rear of the property is a small single storey storage unit.


