

Location

Claywheels Lane is located a short distance from the main arterial route of the A61 Penistone Road. The site is approximately 2 miles North West of Sheffield City Centre and is located within a popular and established commercial location.

Penistone Road is the main arterial route linking the City to the North via the A61 which in turn provides access to J36 of the M1 motorway.

Description

Niagara Forge comprises a majority concrete open storage site which can be split in to small plots ranging from 0.25 acres. The site benefits from perimeter fencing and will have a shared access with the neighbouring occupier. The site benefits from connected mains water and electricity services.

Accommodation

The site can be split in to smaller plots ranging from 0.25 acres to 2.45 acres.


