### Location

The property is located fronting Daleside Road which is a key arterial route on the immediate Eastern fringe of Nottingham City Centre. The building is positioned adjacent to the East Point Retail Park (Aldi, Costa, Smyths Toys, Poundland). To the immediate west is KFC, Harley Davidson and the Lady Bay Retail Park (Dreams, The Range, ScS). The highly visible position fronting Daleside Road (A612) provides superb profile for any business.

# Description

As can be seen from the aerial photograph, the property comprises a series of interconnecting bays of steel frame with a mix of lightweight steel trussed support and traditional portal beams to. The elevations are of a brick construction, with the roof recently replaced to provide a warranty backed covering.

The buildings are serviced with some forecourt parking, level access loading and a side yard for loading and additional parking.

The landlord is prepared to consider adaptation of the footprint to accommodate interest.


