Description

Location

The subject premises are situated on Kettlebridge Road, Sheffield. Sheffield City Centre is located 2 miles to the East and Junction 33 of the M1 is approximately 5 miles to the West of the premises. The unit forms part of the Parkway Works business park, which is a multi tenanted business park providing a manned security gate entrance.

Description

The property comprises a majority single storey industrial unit and associated external area. The unit provides multiple loading door access and integral office accommodation spread over 2 floors.

Externally the unit provides a shared yard.



The property comprises a single story industrial unit surmounted beneath a pitched roof. Entrance to the warehouse section is via a roller shutter entrance with a separate entrance to the gable end.

A separate personnel entrance leads to a two story office section to the front of the unit. Externally the unit forms part of the Parkway Works site which provides shared hardstanding/parking areas.


