Location

The accommodation is situated on Green Lane forming part of the Westthorpe Fields Business Park, south of Sheffield city centre and close to Killamarsh. The accommodation is easily accessible from Junction 30 of the M1 Motorway, via the A6135 main road.

Description

Unit 6E forms part of a terrace of six units comprised of steel portal frame construction with part brick and part metal profile clad elevations. The property also provides shared on-site car parking and good loading facilities. Entrance to the premises can be gained via the personnel entrance or the roller shutter door, leading from the yard area. The unit benefits from a mezzanine storage area and good quality integral office accommodation.

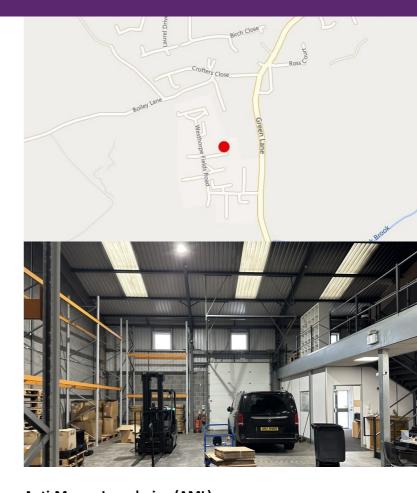
