The unit has two ground level loading doors, internal office / reception provision, WC facilities and kitchenette with allocated external loading and parking areas.

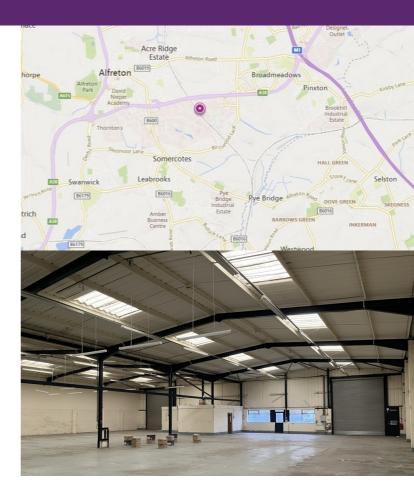
